EMERGENCY SHELTER FOR MEN: THE ORGANIZATION PROVIDES A SAFE, SANITARY, TEMPORARY RESIDENCE FOR APPROXIMATELY 180 HOMELESS MEN A YEAR; PREPARING AND SERVING THREE MEALS PER DAY AND SUPPLYING CLOTHING AND PERSONAL CARE ITEMS AS NEEDED. HOPE HOUSE RESCUE MISSION STRIVES TO OPERATE AS MORE THAN SIMPLY AN EMERGENCY SHELTER BY OFFERING SERVICES DESIGNED TO PROMOTE LONG-TERM, SUSTAINABLE LIFE TRANSFORMATION. CASE MANAGEMENT IS ONGOING DURING AN INDIVIDUAL'S STAY WITH THE GOAL OF ACHIEVING LONG-TERM STABILITY. DURING THE FISCAL YEAR, 194 PERSONS WERE SERVICED AND 10,207 SHELTER NIGHTS AND 55,124 MEALS WERE PROVIDED.

EMERGENCY SHELTER FOR WOMEN & CHILDREN: THE ORGANIZATION PROVIDES A SAFE, SANITARY, TEMPORARY PLACE FOR APPROXIMATELY 250 HOMELESS WOMEN AND CHILDREN A YEAR TO STAY; PREPARING AND SERVING THREE MEALS PER DAY AND SUPPLYING CLOTHING AND PERSONAL CARE ITEMS AS NEEDED. LIKE THE MEN'S EMERGENCY SHELTER, THE CENTER OF HOPE STRIVES TO OPERATE AS MORE THAN SIMPLY AN EMERGENCY SHELTER BY OFFERING SERVICES DESIGNED TO PROMOTE LONG-TERM, SUSTAINABLE LIFE TRANSFORMATION. CASE WORKERS ASSIST THE INDIVIDUALS AND FAMILIES BY DEVELOPING ACTION PLANS BASED ON THEIR NEEDS, WITH THE GOAL OF ACHIEVING LONG-TERM STABILITY. DURING THE FISCAL YEAR, 223 PERSONS WERE SERVICED AND 11,912 SHELTER NIGHTS AND 24,226 MEALS WERE PROVIDED.

THE HOUSING PROJECT HAS BEEN USED TO AID APPROXIMATELY 20 FORMERLY HOMELESS MEN A YEAR STABILIZE THEIR LIVES AND BECOME SELF-RELIANT, PRODUCTIVE MEMBERS OF SOCIETY.
